This report contains important information regarding the water quality in our water system. The source of our water is surface water and groundwater. Our groundwater is drawn from an alluvial aquifer. Surface water is purchased from Council Bluffs Water Works.

Our goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect your water resources. We are fully committed to ensuring the quality of your water. DEFINITIONS

- Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Ppb – parts per billion.
- Ppm – parts per million.
- N/A – Not applicable
- ND – Not detected
- RAA – Running Annual Average
- LRAA – Locational Running Annual Average
- IDSE – Initial Distribution System Evaluation
- SGL – Single Sample Result
- TCR – Total Coliform Rule
- Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.
- Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- LOD – Limit of Detection
- LOQ – Limit of Quantitation
- Maximum Residual Disinfectant Level Goal (MRDLG) – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Maximum Residual Disinfectant Level (MRDL) – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. Some people may be more vulnerable to contaminants in drinking water than the general population. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Regional Water is responsible for providing high quality drinking water, but cannot control the variety of materials used in your plumbing components. When water has been sitting in your private plumbing for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. SOURCE WATER ASSESSMENT INFORMATION

The Regional Water Rural Water Association water supply obtains its water from the sand and gravel of the West Nishnabotna River shallow alluvial aquifer. The alluvial aquifer was determined to be highly susceptible to contamination because the characteristics of the aquifer and overlying materials allow contaminants to move through the aquifer fairly quickly. The wells will be most susceptible to activities such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. A detailed evaluation of your source water was completed by the IDNR, and is available for review at Regional Water Rural Water Association's Main Office at 108 Highway 59, Avoca, Iowa.
